INAUGURAL ASIA-PACIFIC PCI COMMUNITY MEETING ATTRACTS GLOBAL PAYMENT SECURITY LEADERS

—More than 300 convene in KL to discuss global data breach forensics, technology trends in payments and securing card data with PCI Standards—

KUALA LUMPUR, Malaysia, 21 November 2013 — Today the PCI Security Standards Council (PCI SSC), an open, global forum for the development of payment card security standards, announced the close and recap of its first ever Asia-Pacific Community Meeting. The forum provides global PCI Participating Organizations and assessors the opportunity to come together and discuss the latest updates and challenges in payment card security.

- Emerging technologies in payments, including mobile payment acceptance, cloud computing and tokenization
- Insights into achieving and maintaining PCI DSS compliance by implementing a security lifecycle
- Real-life challenges and best practices for addressing payment security from industry practitioners, including Australia Post and KPMG

"With the increasingly global nature of cybercrime and a fast-moving technology environment, the active and growing involvement of the APAC region is critical to securing payments here and around the world," said Bob Russo, general manager, PCI SSC. "We're incredibly pleased

with the meeting turnout and look forward to continued collaboration with our colleagues in Asia-Pacific."
