PCI SECURITY STANDARDS COUNCIL ANNOUNCES SPECIAL INTEREST GROUP ELECTION RESULTS

—Security awareness and penetration testing selected as priority issues by PCI community for 2014—

WAKEFIELD, Mass., 05 December 2013 — Today the PCI Security Standards Council (PCI SSC), an open, global forum for the development of payment card security standards, announced the election results for 2014 Special Interest Group (SIG) projects. SIGS are PCI community-led initiatives that address specific areas or security challenges in relation to the PCI Standards.

PCI Participating Organizations, including merchants, financial institutions, service providers and associations, voted on the ten proposals submitted by their peers and presented for consideration at the 2013 PCI Community Meetings. These topics were selected for exploration in 2014:

- Penetration Testing Guidance (Internal & External)
- Best Practices for Implementing a Formal Security Awareness Program

Over the next couple weeks Council SIG leads will convene each group to formalize the group charter and precise scope of work, before kicking off the projects in January 2014.

"The community had to choose between ten strong proposals from their peers, so it was certainly not an easy decision," said Bob Russo, general manager, PCI SSC. "Again, we are encouraged by how many Participating Organizations were involved in the submission and

election process this year. SIGS continue to be an excellent vehicle for leveraging their expertise in the work we're doing to increase payment card security globally."
